Hello Members and Supporters of the Bicycle Access Council.

It's a beautiful day in Pennsylvania!

#### **BICYCLE SAFETY LEGISLATION PASSES...**

AND IS SIGNED BY THE GOVERNOR ON FEBRUARY 2. Formerly referred to as House Bill 170, the official designation is now known as Act 3 of 2012. After more than three years of drifting through the General Assembly, bicyclists have a clearer set of Vehicle Code statutes to increase the margin of safety as legitimate roadway users. The new law requires specified overtaking [passing] rules and guidelines whenever drivers interact with bicyclists. Act 3 becomes law in 60 days — mark your calendars to celebrate on April 2.

Act 3 of 2012 amends the Pennsylvania Vehicle Code, Title 75. The majority of changes will be found in Chapter 33, Rules of the Road.

Here are the material elements of Act 3 in each sub-chapter section context:

§ 3301(c) states [bicycles] shall keep to the right, except:

when using any portion of the roadway due to unsafe surface conditions, and when there is only one lane of traffic in one direction (ed: control the lane allowed)

- § 3303 (a) (3) states motor vehicles overtaking on the left of a bicycle shall pass not less than 4 feet at a careful prudent reduced speed.
- § 3307 (b.1) states it is permissible to pass a [bicycle] in a no-passing zone, and shall pass in accordance with the four foot minimum distance shall be done in accordance with other overtaking requirements (§ 3305).
- § 3331 (e) Interference with [bicycles] Right Hook prohibition when proceeding straight.
- § 3364 (b)(2) Minimum speed regulation. Slow moving vehicle to drive off roadway,

[bicycles] may be operated at a safe and reasonable "appropriate" speed, [bicycle] operator shall use reasonable effort not to impede normal traffic

Ed note: The term [bicycle] is used in place of Pedalcycle found in the actual statutes. Full amendment text not used here.

BAC was not present when Governor Corbet signed Act 3 even though a request to be there was made directly with the governor's office. The governor had ten days to sign the bill from the time it arrived on his desk, January 26. A mock signing ceremony is being planned so as to include as many individuals and organizations who helped promote and lobby for this bill to pass to attend.

The agenda will also devote time to explaining the new Bicycle Safety legislation, Act 3 of 2012. Club leaders must be prepared to respond to the public, as well as, their own club members as to what the new Vehicle Code amendment really means and how it will be promoted.

PennDOT is expected to send a representative to update and explain policies and operations important to bicyclists.
