It's a beautiful day in Pennsylvania!

APRIL MARKS THE SECOND ANNIVERSARY OF ACT 3, ...

The landmark Bicycle Safety legislation that gave Pennsylvania bicyclists a greater margin of safety on the road. Here's a summary of the Vehicle Code as amended with references to the actual statute section number as found in Title 75:

§3301(b)2(ii)	Bicyclists must keep to the right as far as practicable —
	<i>unless</i> unsafe to do so or when preparing to change lanes
§3301(c))(ii)	Bicyclists may "control the lane position" on two-lane, two-way roadways
§3303(a)3	Motorists must allow a minimum of four-feet to overtake [pass] a bicyclist
§3307(b.1)	Motorists may cross a centerline to maintain a four-feet passing distance —
	when safe to do so. See §3303(a)(3) and §3305
§3331(e)	Motorists may not make turns to interfere with bicyclists proceeding straight —
	an intended "right hook" prohibition*
§3364(b)2	Bicyclists may not be cited for impeding traffic —
	while operating at a reasonable speed for bicycling conditions

*The intent and the narrative description of §3331(e) was incorrectly given in PennDOT's 2012 press release to the media and remains incorrect on its website referring only to left-turning motor vehicles. BAC has pointed this out many times asking for a correction, but to no avail. §3322 requires left turning traffic to yield to any oncoming vehicles and sufficiently protects all vehicles and was not amended by Act 3.

SENATE BILL 997 PASSES UNANIMOUSLY...

On March 31 to add "Electric Assist" pedalcycles [bicycles] to the Vehicle Code. It now moves on to the House Transportation Committee for consideration. Meanwhile, House Bill 213, a bill with identical language that BAC worked to craft in 2010, still has not been scheduled for any hearing and a House spokesman says it won't be considered anytime soon. The bill(s) would allow electric-assist bicycles with certain features to be used on Commonwealth roadways. Currently they are not "street legal" as defined by PennDOT, regardless of claims by dealers that they are. SB 997 or HB 213 does not address use on *non-motorized* trails or paths.
